Council Commitment – Invoicing & Payments

Individual participant Jamboree fees:

- \$975 - Youth participants
- \$487.50 - Unit leaders ages 18-25 through July 18, 2017, after which the fee for all adult leaders becomes that for 26+ indicated below
- \$975 - Unit leaders age 26+

Council Commitment – 1st Billing and Fee Payment

Payments against council commitments are required in accordance with the following schedule:

A deposit of \$7,000 per Scout troop or \$1,750 per Venturing patrol (\$175 per person) is due to the National Council on or before January 31, 2016.

Council Commitment – Invoicing & Payments

A payment of \$16,000 per Scout troop or \$4,000 per Venturing patrol (\$400 per person) is due to the National Council on or before July 31, 2016.

A final payment of \$16,000 per Scout troop or \$4,000 per Venturing patrol (\$400 per person) is due to the National Council on or before Jan. 31,

Council Commitment – Invoicing & Payments

- Late Fees will be assessed as follows:
\$2,000 per Scout troop or \$500 per Venturing patrol (\$50 per person) late fee will be assessed the day after each scheduled payment due date (*i.e., February 1, 2016, August 1, 2016 & February 1, 2017*).

Council Commitment – Invoicing & Payments

- Changes to a Council's final commitment can be made until November 30, 2016.
- Requests for refunds resulting from a change in the overall size of a council contingent will be evaluated on a case by case basis through April 30, 2017.
